



Smart Multipure 5.0

Installation Instructions

Open the box and check availability of below accessories required for installation:

Brass ball valve, 3 way connector, PL4 pipe white and blue, Tap/Taflone, Gitty & Screws

1. Choose an appropriate water connection point.
2. Please note water purifier unit should be connected to normal temperature water supply only. Hot water supply is not recommended for water purifier connection.
3. Fix 3 way connector or SS Ball valve with the help of a pipe wrench at this water point to separate water supply for water purifier. Keep ball valve in lock condition.
4. Fix the machine at a suitable place on the wall near to input water connection.
5. Kindly ensure fixing is not inclined. On a inclined unit will be hanged inclined and it may result in float valve malfunctioning/water outflow from unit.
6. Connect Input Water pipe (White) at the inlet connector in the unit. Cut the excess pipe length, do not fold/round it.
7. Now fix the power adaptor into a 3 pin, 5A 230VAC electrical socket.
8. Switch ON the main switch.
9. After switch on allow water to drain from all filters by removing the outlet pipe of each filter.
10. While draining filters, kindly ensure water is not spilled onto any electrical/electronic part and allow it to dry.
11. Check for any leakage from piping & fittings/loose fittings. If any pipe is found loose then reinsert it into the connector to avoid leakage later.

11. Allow water storage tank to fill completely and discard the first fill.
12. You may use this water for floor/utensils cleaning and gardening of plants instead of draining.

Note:

1. Use a pre filter cartridge
2. Input raw water temperature should be between 10°-40° C
3. Total dissolved solids in input raw water should not exceed 750ppm
4. Raw water should be free from oil & grease
5. Permissible iron content in raw water is 0.3mg/l (max)
6. Total hardness in input raw water should not exceed 200 mg/L (max)

Warranty Terms & Conditions

All products manufactured by BluAct Technologies is meant to be free from defects in material and workmanship, however since the nature of products demands usage the company restricts its warranty limit under the defined guidelines mentioned below:

1. The product is warranted against any manufacturing defects arising out of any faulty or defective material on workmanship for a period of 12 months on electronic and 6 months on filters & one year on RO membrane from the date of final invoice to customer.
2. The responsibility of BluAct under this warranty will confine to the first purchase only and not apply or extent to any subsequent sales of the product by the customer.
3. The liability of BluAct under this warranty shall remain valid if and only if the product is fully installed by the company, its authorized dealer /service provider at the address specified in the invoice or where the installation is at the place other than specified in the invoice. Such installation should be undertaken with the consent in writing of and by the company confined to cities where company has service network.
4. Inspection & test report of the BluAct service center will be treated as final & binding under the warranty for determining defect, repairs/alterations required or carried out, or certifying working of the goods thereafter.
5. The liability of BluAct under the warranty will be limited only to defect which occur under normal condition operation and under proper use as defined in manual. It excludes defects occurring because of misuse, faculty care or maintenance, repairs/alternations to goods or parts by others.
6. The Consumer shall have no claim under this warranty in respect of death/injury to any person or loss/damage to any property caused as a result of equipment failure, breakdown or accident on utilization of goods not in accordance with the inflections in this user's manual or any other circumstance beyond the control of BluAct.
7. Any disagreement and obligations based upon purchase of BluAct products and thereby imposed on BluAct or its authorized service providers shall be governed and construed according to the laws of INDIA.
8. BluAct reserves the right to make design and product changes or change specifications at anytime without any contingent obligations to prospective buyers or owners or products previously sold. However, BluAct will ensure periodical update on product changes made available to its seller as found appropriate.
9. Under no circumstances the terms mentioned above are negotiable and no employee of BluAct or its authorized service provider has the authority to supersede the terms mentioned above.
